1.2 Details of the alleged contravention

While no formal contravention of the *Work Health and Safety Act* 2012 (SA) (**WHS Act**) has been alleged, BTG understands the correct characterisation to be an

alleged contravention of s 20 of the WHS Act with respect to an incident involving the partial collapse of Deltacore at a BTG site, on 26 September 2019.

1.3 Detail the events surrounding the alleged contravention

A worker was performing works at a site in Bowden including concreting the floor on level 5 of a BTG construction site when a Deltacore panel fell through to level 4. Consequently, the worker also fell through to level 4.

Detail any current work, health and safety systems at the workplace 1.8

The regulator has been provided with BTG's WHS Management Plan in place for the project. This document provides a high-level overview to BTG's approach to safety.

Each project undertaken by BTG has in place its own site specific WHS Management Plan.

1.9 Detail the level of auditing currently undertaken on the work, health and safety systems referred to in term 1.8, including compliance audits and audit frequency

Auditing can vary subject to the complexity and length of particular jobs.

There are fortnightly safety meetings at each site. These meetings are led by a director of BTG and comprise the site team (typically a project manager, contract administrator and site supervisor). At these meetings safety processes are reviewed, which includes but is not limited, reviews of SWMS based on site conditions and impending work requirements. BTG also undertakes regular reviews of its projects, which may include reviews at policy and procedure level as well as site reviews etc.

BTG conducts an annual review of safety management system and there is ongoing monitoring of BTG's online safety management system SiteBook.

1.10 Detail the consultation undertaken or proposed to be undertaken, in relation to this undertaking

BTG has engaged with its management in relation to the creation and proposed implementation of its EU proposal. This has also included consultation with its own workforce and the injured worker.

If the EU proposal is accepted, once implemented, BTG contractors will be immediately brought on-board with respect to the operation of the undertaking.

1.11 Detail the rectifications to the workplace or work practices made as a result of the alleged contravention and the enforcement notices issued

The installation of Deltacore panels and structural design was reviewed and systems revised as follows:

- Tower Crane Hire and crane crew is subcontracted to Titan cranes. The Lifting SWMS was reviewed by Titan Crane Hire with specific reference to Deltacore. This led to an update to include further reference to specific Deltacore Lifting and storage requirements. This was previously a separate document.
- Operationally, once Deltacore is placed in position by the crane crew, any final
 positioning of planks, site cut outs and installation of reo-bars is completed by our
 subcontract labour crew from Ambush. The SWMS for this process was reviewed
 and updated with input from all, including the BTG site manager.
- Additionally, concrete topping to complete the structural design is now poured by subcontract company Caiazza Concrete. Specific reference to placing topping slabs to Deltacore has been reviewed and the SWMS has been expanded at 12A to include evidence on pre pour inspection.

- BTG also ensured the structural design was reviewed with PT Design, the project structural engineer. Following the review, it was determined that side cuts for tie bars would be a maximum embedment of 300mm in lieu of the typical 600mm.
- Finally, it was also determined that all planks requiring on site cutting would be propped prior to cutting, with such propping remaining until the topping slab has cured.

SECTION 2: GENERAL TERMS

The person acknowledges and commits to the general terms set forth in the sub-terms below.

2.1 Acknowledgement that the regulator alleges a contravention occurred as detailed in term 1.2

BTG acknowledges that the Regulator has alleged that BTG contravened sections 20 and 32 of the Act. Specifically, failing to provide a workplace that is without risks to the health and safety of any person.

2.2 Statement of regret that the alleged contravention occurred and the reasons the person considers this undertaking is a more appropriate response to the alleged contravention than a court imposed sanction

BTG deeply regrets that the alleged contravention occurred. As a company involved in inherently dangerous work we have always taken pride in the level of safety provided for all our workers. It is particularly distressing, therefore, to know that this incident occurred and that the worker was injured as a result.

This is BTG's first alleged contravention of the WHS Act as a result of the incident on 26 September 2019. BTG takes pride in the work it undertakes and the working environment it provides for its workers. On that basis, BTG is a good corporate citizen.

The nature of the proposed undertaking, set out below, is preferable in all the circumstances both in relation to the direct assistance to the community provided and also the significant public and industry benefit gained from the training and awareness program proposed.

In our submission, such an outcome outweighs any benefit to the public expectation with respect to the imposition of a court-imposed sanction.

2.3 Statement of commitment that the behaviour, activities and other factors which caused or led to the alleged contravention has ceased and will not reoccur

BTG is committed to continuous improvement in its approach to workplace relations management.

BTG has developed a specific SWMS for the activities that gave rise to the incident.

Further, as part of this undertaking, BTG is committing itself to enhance and upgrade its safety management system.

 - 3.10.1 The recommendations resulting from the WHSMS audit will be fully within six months of receiving the audit report, unless the regulator offers a variation of the undertaking due to the actions being unreasonable.
